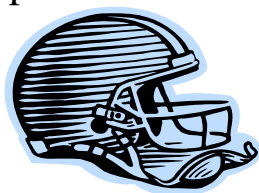
The successful Zumba classes are now meeting at Santa Fe Community College (Archer) on Mondays at 4:30 and 6:00 PM.

# FLORIDA HISTORY CORNER:



## OSCEOLA

Asi-yaholi (called Osceola by people who couldn't pronounce his name) had reason from earliest childhood to hate white people. Andrew Jackson raided his tribe, and Osceola's family fled to the south and joined the Seminoles in what is now Alachua County.

The Treaty of Moultrie Creek (1823) offered Seminoles a reservation and cash annuities. But white people wanted the land, which had rich soil, and, in a gross violation of the treaty, Congress passed a law in 1830 called the Indian Removal Act, which stated that all Indians must be removed from Florida.

Wiley Thompson, the Indian agent at Fort King (in what is now Ocala), was furious with Indian chiefs who refused to go west. A few chiefs agreed and signed the document, but the young Osceola stabbed the document with his knife, saying, "The only treaty I will execute with is this!"

Thompson had Osceola arrested and put in prison. Later, Osceola agreed to sign the removal document, and Thompson freed him

and gave him a rifle as a gift. He did not suspect that Osceola would later kill him with that very rifle.

On Dec. 28, 1835, Major Francis Dade led 108 men from Fort Brooke towards Fort King. Chief Micanopy and his men attacked, killing all but two of Dade's men.

That same day, Osceola went to Fort King and shot and killed Wiley Thompson.

In October of 1837, General Thomas Jesup persuaded several Seminole chiefs to surrender. Osceola told Jesup he would discuss a treaty, but only under a flag of truce. Jesup agreed. But he violated the truce and had Osceola and the Indians with him captured and sent to the prison at the fort in St. Augustine. Later Osceola was transferred to Fort Moultrie, an island prison off the coast of South Carolina.

Jesup spent the rest of his life trying to justify his actions to those who disapproved.

At Fort Moultrie, Osceola contracted an inflammation of the tonsils called quinsy. When he found out his doctor was the brother-in-law of Wiley Thompson, Osceola refused treatment. On January 30, 1838, Osceola knew he was about to die. He called his people and the doctor together, shook hands with each of them, then lay down with his knife on his chest and died.

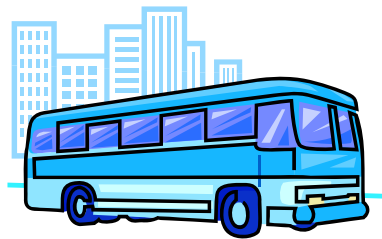
## City choosing Engineering firm to look into City Sewer

The city has entered into discussions with Baskerville Donovan out of Lutz Florida for the purpose of examining the feasibility of the city developing a city sewer system. Pending

successful contract costs Baskerville-Donovan will provide a three phase scope of services which will define costs, funding mechanisms and potential service areas for a proposed system.

## City Codes Enforcement

With the summer growing season on us we ask that every one make an effort to keep our yards and vacant properties mowed and cleaned up. We also are seeing a number of disabled or junk cars showing up in yards and lots around town. Both of these issues are codes violations. We ask that citizens make every effort to keep their properties mowed and remove junk or abandoned vehicles from their properties so that codes issues do not develop. Call City Hall if you have junk or abandoned vehicles, we can provide contacts to businesses that help in the removal of them. The City is considering Minimum Housing Maintenance Standards for dwellings within the city. These standards will help allow for the identification and repair of substandard dwellings and the removal of dwellings declared unsafe by the Archer codes board.
